This is to confirm the agreement between _____ and Dreamers Creative Writing (“Dreamers”).

1. WORK. You agree to contribute an essay, story, poem(s), review, or article (the “Work”), identified as follows:

2. RIGHTS GRANTED. You grant Dreamers the following intellectual property rights for the Work:

- A. Worldwide Serial Rights (non-exclusive publication of the Work in the Dreamers print magazine).
- B. From the date of this Agreement, the nonexclusive right to publish the Work on Dreamers World Wide Web site and sell the Work throughout the world in digital format (digital format includes Internet, disk, electronic download, CD, or any other digital format known or unknown at this time).
- C. A nonexclusive worldwide right to include the Work in anthologies, reprint editions, adaptations, or collections of articles.
- D. The nonexclusive right to use selections from the Work in the advertising and promotion of Dreamers and the Dreamers web site.
- E. All rights to the Work not specifically granted above are reserved by you. You retain copyright to the Work and may republish it at any time at your sole discretion.

3. WARRANTY. You warrant that to the best of your knowledge, the Work does not violate or infringe any copyright, trademark, contract, or proprietary rights of others, or contain anything libelous or defamatory, and you agree to indemnify and hold Dreamers harmless against any final judgement resulting from the falsity of the foregoing warranties.

4. COMPENSATION. Within 30 days of the Work’s initial publication in compensation for the rights granted to Dreamers under Section 2 above, Dreamers shall pay you a sum of \$20 CAD for 1-3 poems or 1 short fiction or non-fiction story or essay of up to 3000 words; \$60 CAD per feature or review; \$250 CAD to first place winners of the Dreamers Stories of Migration, Sense of Place and Home Contest; \$120 CAD to first place winners of the Dreamers Micro Nonfiction Story Contest; \$120 CAD to first place winners of the Dreamers Haiku Contest; \$150 CAD to first place winners of the Dreamers Flash Fiction and Nonfiction Contest; \$50 CAD to second place winners of any of the Dreamers writing contests; \$20 CAD to honourable mention winners of any of the Dreamers writing contests; and if published in print, you will receive 1 print and 1 electronic copy of the publication in which your work appears.

5. EDITORIAL CHANGES. Dreamers may make minor revisions/edits to the Work, and may code the work in HTML as needed for Web presentations, but will make no substantive changes in text or title without your permission.

6. MISCELLANEOUS. No modification to this Agreement shall be binding unless made in writing and signed by the parties hereto. This agreement shall be deemed executed under the laws of the province of Ontario, Canada. The parties acknowledge that each party has read and understood this contract before execution.
